What is ICON EXPO 2018: Machinery & Equipment Show?

- ICON EXPO is produced and owned by the National Concrete Masonry Association (NCMA). This NEW event, launching in 2018, is the only trade show completely dedicated to the manufactured concrete masonry and hardscape industry. The show is endorsed by the Interlocking Concrete Pavement Institute (ICPI).

When is ICON EXPO 2018?

- ICON EXPO will be held February 9 -10, 2018 at the Indianapolis Convention Center, 100 South Capitol Avenue, Indianapolis, IN 46225.

What are the show hours?

- Friday, February 9, from 11:00am to 6:00pm
- Saturday, February 10, from 8:00am to 5:00pm

What can we expect on the show floor?

- 75,000 square feet of exhibit space will showcase state-of-the-art machinery, products, services, and the latest equipment for the manufactured concrete masonry and hardscape products industry, along with demonstration areas, virtual plant tours, lighting talks, entertainment and much more.

When will registration open?

Is ICON EXPO 2018 open to the public?

- No, ICON EXPO is only open to trade industry professionals.

Can we take pictures at the show?

- The use of cameras, cell phones or any electronic devices to take still or moving images is STRICTLY PROHIBITED on the show floor. Only approved ICON EXPO photographers and members of the press with proper credentials are exempt.

Where can I pick up my badge?

- You will be able to pick up your badge in the registration area beginning February 8, 2017 in the Indianapolis Convention Center. Registering early provides a smooth onsite experience at the Scan and Go center.
